91. Police Liaison

- PC Crossman reported that Central/Wexham are now fully manned
- Anti-Social behaviour is down in the area
- Central/Wexham have become quieter
- Burglaries have decreased by 18% in the area
- Some arrests have been made due to which groups are less on street corners
- Communities asked to report any incidence in the area to the Police
- Bike was stolen at the Care home- Marking can be done check online (website)
- People wants more visibility around School at exit times
- People reported that selling of Kitchen Knives was being done door to door - is it legal and has anybody been caught
- People asked that Police be more vigilant and visible during the school half term
- There are Four officers allocated to Central/Wexham area

- Cllr Gahir raised the issue of rubbish on Frith and also mentioned that the Council should consider Cameras for the Shops- questions were raised if the shops would consider a contribution
- Cllr Fayyaz reported that alleyway from School and Bell Close and Mansell close a lot of nuisance is being created-Cllr Malik and Clerk to investigate

- Cllr Aldridge enquired about double yellow line in Wexham and reported on Pavement parking on verges on Knowlton Way and between the Normans and the shops
- Cllr Malik reported that the Tile/Roofing outlet on Stoke Road will be converted to a Community Center ALSO the bus stop in Wexham Road near the Post office needs a Bus Shelter
- Cllr Dar reported that on the Frith between 44-68 the verge is going to disappear and any parking on verges will attract fines. Car Park on Sheey Way is under consideration for Housing
- Cllr Khan attended the Parish Forum where the issue of Bus service to the Wexham Parish Hall was raised and mentioned that Notice Boards were required near the Shops and at Upton Lea
