The Parish Council is waiting for Slough Borough Council response.

- It was pointed out by a Councillor Ken Wright that some Salary cheques were signed by previous Councilors Sarfraz Khan and Shahida Akbar- the Clerk confirmed that he had asked them to sign the cheques. The Council may convene a meeting in Part 2 to look into this matter further.
- The Clerk was asked to provide a complete set of keys for the wexham court parish hall and offices to the Chair, V Chair and Cllr Hamilton. Also to provide a list of all the Key Holders.
- The Council authorize the Chair to investigate the Parish Website design
