
**01092021-10 Clerk and RFO update & correspondence**

Clerk reported the following:

- Sports Courts UK Ltd are chasing payment and have been put on the July/August 2021 payment list.
- Draft S.106 has been sent to WCPC by HB public law in relation to Land North of Norway Drive and we have made our initial comments thus, we are now waiting for a response.
- Had a meeting with SUR on how they will be carrying out the S.106 improvements to our retained land. The final plan will be brought to full council for its approval.
- Hall booking are steady as restrictions have been eased.
- We have approached SBC in relation to the potential acquisition of the Wexham court parish hall and bowls club as well as surrounding land. In addition, to requesting the acquisition of the land adjoining the current allotments in order to carry out expansion of this facility.
- The charges to the allotment holders should be reviewed and they should be invited to attend a committee in order to air their concerns if any.
